



## **Stockholm Netball Club's General Data Protection Regulation ("GDPR") Privacy Policy**

### **Introduction**

Thanks for wanting to join the Stockholm Netball Club ("SNC") community! At SNC, we want you to have a fun netball experience in a safe environment. To make this possible, we must obtain a few pieces of personal data from you.

SNC understands the importance of the privacy and security of your personal data, so we would like to explain to you how and why we collect and use your personal data. Alongside this, we would like to make you aware that you may control the use of your personal data.

### **Who is collecting the data?**

SNC are committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your SNC membership, SNC is the Data Controller of this personal data and is responsible for storing and otherwise processing that personal data in a fair, lawful, secure and transparent way under GDPR.

### **What of your data is being collected?**

SNC understand that you may provide us user data by filling in online forms (such as a registration form), signing up to our newsletter, completing surveys, making payments or by corresponding with SNC by phone, e-mail, Facebook, Instagram or otherwise.

This information shall collect but is not limited to, your name, date of birth, address, e-mail address, phone number, gender, date of birth, nationality, residence, next of kin, contact of next of kin, etc. SNC may also ask for relevant health information.

### **What is the legal basis for processing your data?**

The reason SNC collects your personal data is to be able to administer your SNC membership and fulfill our obligation to you to provide the SNC membership services you are signing up to when you register with SNC. Our lawful basis for processing your personal data is that we have a contractual obligation to you as a member of SNC to provide the SNC membership service you are registering for.

### **Will your data be shared with any third parties?**

When you become a member of or renew your membership with SNC you will automatically be registered as a member of SNC. SNC does not supply any personal data it holds for this purpose to any other third party and SNC shall not process your personal data outside of Sweden.

## **How will your information be used?**

We at SNC store your personal data on a secure platform, which is only directly accessible by the SNC Committee for the purpose of SNC. It is vital that SNC receives a valid email address or telephone number, so that SNC can communicate with you and ensure that your personal data is up to date.

We will maintain a database for all current members and this will enable us to communicate with you as and when necessary.

## **How long will your data be stored for?**

SNC will hold your personal data on file for as long as you are a member with SNC. SNC member's personal data is updated every year on annual membership forms. Any personal data we hold on you will be securely destroyed after 1 year of inactivity on that membership account. Your personal data is not processed for any further purposes other than those detailed in this SNC GDPR Policy.

## **Your rights regarding your personal data**

GDPR gives certain rights to individuals in relation to their personal data collected by SNC. As a personal data subject of SNC, you may have the right at any time to request access to your data, to rectify your data, erase your data, restrict the processing of your data, object to the processing of your data, request a copy of your data and to complain to the Data Protection Commissioners Office about the processing of your personal data.

As a personal data subject of SNC, you are not obliged to share your personal data with SNC. If you choose not to share your personal data with us we may not be able to register or administer your SNC membership.
